

Warranty terms and conditions

- The product must not be used in particularly corrosive or aggressive environments, e.g. in air with a high salt content, be in constant contact with water or in contact with e.g. chemicals, smoke, copper, lead, manure, dust, ash and other external corrosion-causing elements.
- The product must not come into contact with wet concrete, wet timbre and pressure-impregnated wood.
- The product must be installed in accordance with DS Stålprofil's installation instructions.
- The product must be installed using DS Fittings and DS Sealing Accessories.
- The product must be maintained and inspected in accordance with the applicable guidelines issued by DS Stålprofil A/S.
- The product is installed at the correct roof pitch.

- The product is not exposed to mechanical effects after it has left the factory.
- Products in a rain shadow must be washed in the correct way.
- The product must be stored correctly before it is installed and installed not more than one month after the invoice date.
- The current owner must be able to submit written documentation that describes the order and/or the invoice number or other proof of purchase.
- A complaint must be submitted to DS Stålprofil A/S no later than three weeks from when the damage was discovered or from when it should have been discovered.
- DS Stålprofil A/S must have the opportunity to inspect the product while it is installed.

Compensation terms and conditions

- When an entitled claim is received in accordance with the warranty terms and conditions, and depending on the evaluation of the product, DS Stålprofil A/S will choose to either recoat the product or supply new products as a replacement for the defective products.
- Liability related to this warranty is limited to the original invoice value and does not cover the costs of removal or re-installation.
- DS Stålprofil A/S is not liable for direct or indirect losses, including production losses, rent losses, consequential damages and damages to the other parts of the building structure or buildings.

- The warranty for the replacement or re-coating of products applies during the remaining period of the original warranty.
- The warranty does not apply to colour differences when products are replaced.
- The warranty does not cover any corrosion formation at sheet edges and around perforations of products.
- The warranty does not apply to the coating on the rear of the products.

Please note that tension-induced bulging in thin plate steel is not covered by the warranty.

This warranty applies to all deliveries made from January 2020.

Maintenance

To ensure the optimal use of steel sheet cladding, it is important that the maintenance stated below is followed. The following points must be checked by inspection:

- There is no dirt accumulations and all of the cladding is clean.
- Flashing is secure, edges sealed with the surrounding materials.
- The cladding is intact. Particular attention is paid to cutting edges.
- Rib strip is correctly in place for optimal sealing.
- Screws and other fittings have not become loose
- 6 Any damage that has occurred is immediately repaired.

Cleaning

It is important that the cladding is cleaned at suitable intervals, however at least once a year. Note that some exterior surfaces may be located in a rain shadow, e.g. facade cladding underneath an overhang. These surfaces must be cleaned more often otherwise greater soiling can build up because there has not been any natural rinsing from rain.

Dirt deposits and similar may be washed off using a soft brush and mild soapy water.
